REGULATIONS

on the Procedure for Expulsion (Students of the Specialist's Degree Programs)

The regulations have been developed in accordance with the Federal Law "On Education in the Russian Federation" dated December 29th, 2012 No. 273-Φ3 (with Amendments and Additions), "The Procedure for Organizing and Implementing Educational Activities of the Educational Programs of Higher Education Including Bachelor's, Specialist's, and Master's Degree Programs" approved by the Order of the Ministry of Education and Science of the Russian Federation dated April 5th, 2017 No. 301; the Charter of FSBEI HE KubSMU of the Ministry of Health Care of Russia (hereinafter referred to as the University).

A student may be expelled from the University in the following cases:

- 1. at one's own request;
- 2. transfer to another educational institution;
- 3. for health reasons;
- 4. conscription into the armed forces of the Russian Federation;
- 5. graduation from university;
- 6. he/she failed to master the main professional educational program and to implement the curriculum:
 - failure to complete the semester curriculum;
 - absence of "completed" mark in the examination subject;
- receiving three unsatisfactory marks in the midterm assessment for one subject (module);
 - missing three or more timesone subject without a valid reason;
 - failure to complete the program of educational and practical training;
 - receiving an unsatisfactory mark on the state final certification;
- 7. losing contact with the university (absence for a month or more). For foreign students absence for two weeks without a valid reason;
 - 8. failure to return from academic leave;
- 9. violation of obligations stipulated by the Charter of the University, internal regulations, rules of residence in the dormitory, and other local acts;
- 10. non-complying with the terms of the agreement for the provision of paid educational services in terms of payment for tuition in the relevant academic year;
- 11. violation of the passport and visa regime provided for by the Federal Migration Laws of Russia and other regulatory documents of the current migration legislation of the Russian Federation;
 - 12. his/her death;
- 13. forgery of documents regulating the educational process, as well as those related to it:
- 14. criminal liability under a court sentence that has entered into legal force;
- 15. expulsion as a disciplinary measure for violation of the "Internal Regulations for Students of FSBEI HEKubSMU of the Ministry of Health Care of Russia" on the grounds and in the manner determined by the Regulations;

16. other cases established by the legislation of the Russian Federation.

Expulsion of a student for reasons specified in paragraphs 13-15 of this Regulation is considered expulsion for an unjustified reason.

Students who have not submitted an application for a vacation after passing the state final certification are subject to expulsion after the reports of the chairmen of the State Examination Commissions on the state final certification.

Expulsion of students is carried out by order of the rector on the proposal of the dean of the faculty after consideration at a meeting of the educational and training commission. With regard to the expulsion of foreign citizens (and stateless persons), the date of expulsion is extended from the moment the decision on expulsion is made for the period necessary for passport and visa registration of departure stipulated by the legislation of the Russian Federation which is reported by the head of the international department.

The day of a student's expulsion is considered to be the date specified in the order, from the moment of which the latter is not allowed to attend classes and is considered to have lost relations with the University.

Students may not be expelled within his/her illness, vacation, academic leave or maternity leave.

Students who receive an unsatisfactory markat the state final certification, as well as those who have mastered part of the educational program and (or) have been expelled from the University, are issued a certificate of study or of the period of study according to a pattern independently established by the University.

When a student is expelled from the University, regardless of the reason for expulsion, upon the student's personal application, a certificate of the established form is issued to him/her personally or to another person with a power of attorney certified in the established manner. After submitting a departure checklist to the dean's office, the original of the educational document from the student's personal file is provided.
